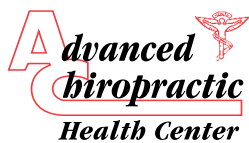

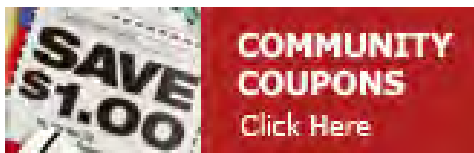

Village Report

Terrence D. Wittman, Village Trustee

The Village Board has approved our annual budget for 2012. We expect to have a slight shortfall with expenditures exceeding revenues by about \$300,000. While we would obviously like to have no deficit spending at all, we had projected a shortfall of over \$1 Million after completing the budget at the end 2010. In the past year we have had a Financial Planning Sub-Committee set up by the Mayor and that process has yielded a number of cost saving initiatives that have helped us close the gap rather well. The Village has also seen an increase in Sale Tax revenues, which means our businesses are doing better!

Part of helping that Sales Tax increase is the fact that we have two healthy Car Dealerships in Roselle, Friendly Ford and Wickstrom Chevrolet. The Village helped Friendly Ford a few years back with some Sales Tax rebates so that they could build out the store and improve it. We have just passed a similar plan with Wickstrom so that they too can be even more competitive in the suburban market place. Both of these businesses are very important to us and we wish them both continued success.

An added bonus going into 2012 is the fact that we haven't had to use much of our Snow removal budget to date. While we all know this can change in a heartbeat, it is nice to save the money on that so far.

As a reminder, we have "Coffee with the Board" the first Saturday of every month from 9 – 10:30am on the Second Floor of the Village Hall, in the Council Chambers. Everyone is welcome and this venue offers everyone an informal place to discuss anything that may be on your mind concerning the Village.
